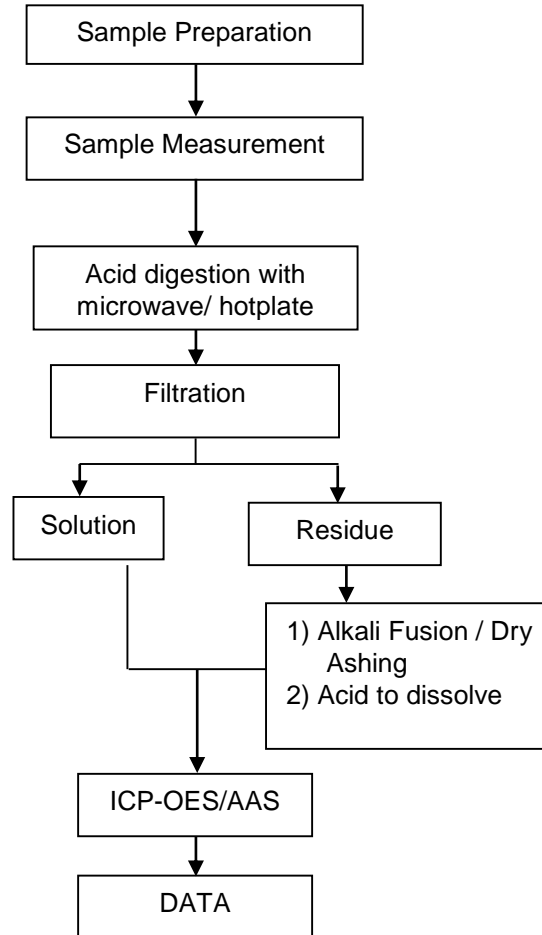

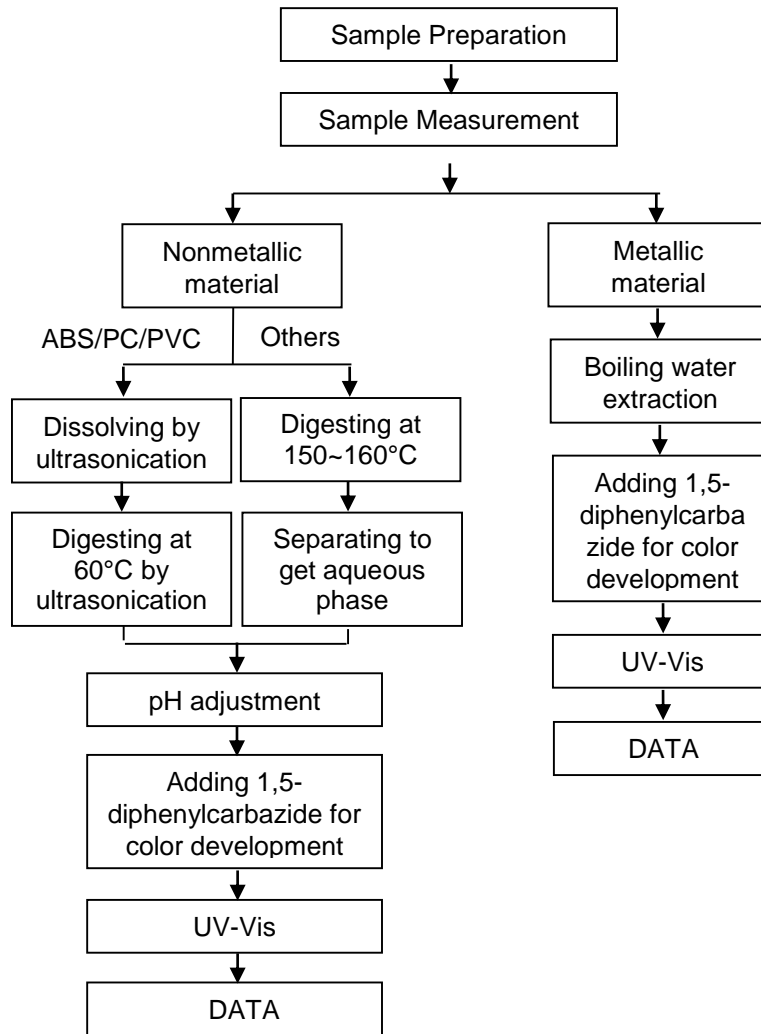

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**

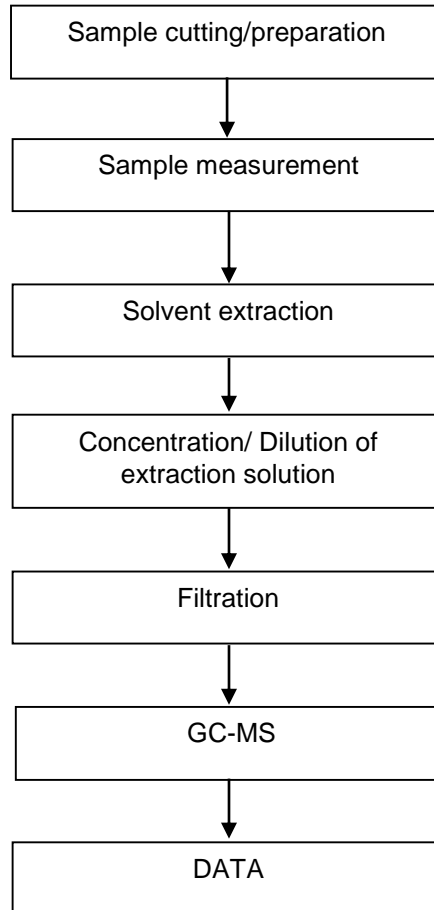

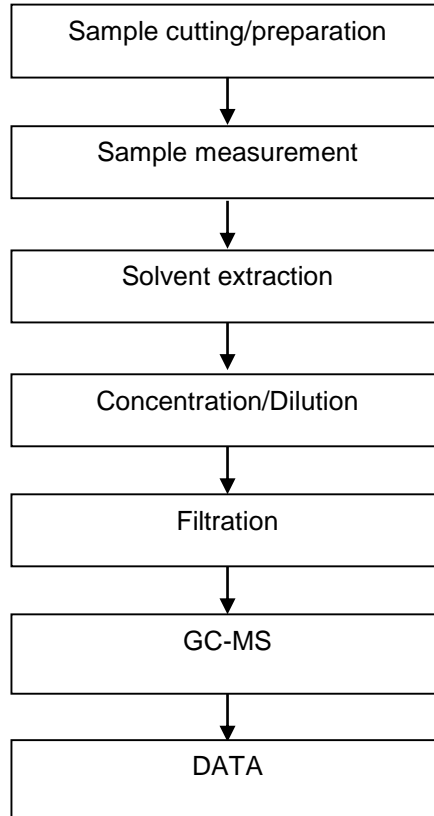
### PBB/PBDE Testing Flow Chart

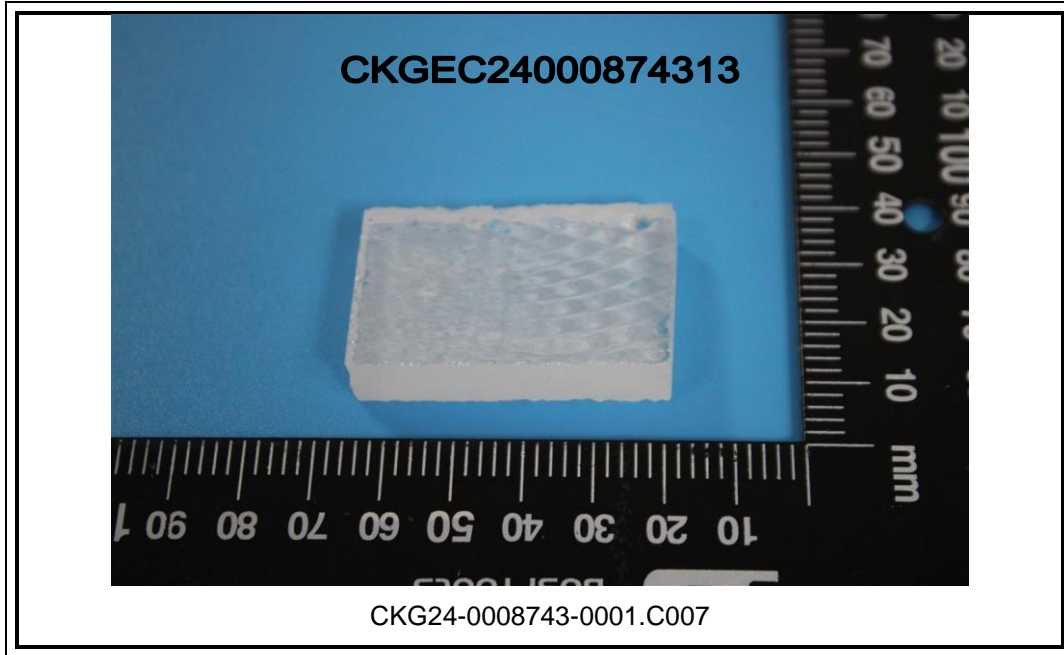
